MILL RATE – Fred Nugent made the motion to approve the mill tax rate for general Township purposes set at 1.03 mills on each dollar of assessed valuation and tax rate for fire companies, the sum of .20 mills on each dollar of assessed valuation, Bob Foltz seconded. Motion carried. **(Res. 11-033)**

PERSONNEL MANUAL – Employee compensation was changed under Employee Classifications for Hourly Employees:

- 1. Hourly Full Time: Those employees who are regularly scheduled to work thirty-two (32) has been changed to thirty-five (35) hours per week to qualify as a full time employee.
- 2. Tier I Hourly Part Time: Those employees who are regularly scheduled to work at least twenty (20) hours per week but less than forty (40) has been changed to thirty-five (35) hours per week.
