#### **NEW BUSINESS:**

- 1) Adams County Rescue Mission Recycling Program Budget Item Request
- 2) Electronics Recycling Event Update

Supervisor Socks stated that the Rescue Mission would like to restart their electronics recycling. They are trying to raise \$24,000. Adams County agreed to \$12,000, and the 34 municipalities need to come up with the other half. We donated \$250 in our budget. Mr. Socks stated they get money out of this program

from the recycling, so I am at a loss, as to why we have to fund a program that gets money. Supervisor Danner agreed and stated the County should find other alternatives, and not put the burden on townships. The Secretary was instructed to find out from the County what the computer/TV recycling program includes, and if they will accept tube TV's and LCD TV's.

Supervisor Socks stated that Affordable Computer's has informed us that their primary source for disposal of tube TV's and monitors, which is Penn Township, is no longer taking them. Affordable Computer's second source charges \$0.40 per pound to take these items. Due to the incurred expense, we will be limiting drop offs of tube TV's and monitors to township residents only, and will request to see their ID. Mr. Socks stated do we increase our donation to the Mission for this recycling request, or pay \$0.40 per pound for the January 9th event? Supervisor Black stated we should wait until after the event is over to see how it goes. The Secretary was instructed to put a second flyer on the office door and recycling trailer, stating tube TV's and monitors will only be accepted from township residents, and will be asked for ID if they drop off these items. Supervisor Cockley made a motion to pay \$0.40 per pound for CRT TV's and monitors, limited to township residents only, seconded by Supervisor Socks. Roll Call: Black — yes, Cockley — yes, Socks — yes, Danner — yes, Foltz — yes. Motion carried.

- 3) Energy Distribution Company Quotes for Rates and Terms The Board agreed that the contracts should be reviewed to make sure they are not giving introductory rates, and that gross tax receipts are included in the KHW rate. Mr. Danner will review this information, and it will be discussed at the next meeting.
- 4) Pension Plan Disclosure Statement (Act 44) Supervisor Socks made a motion to adopt the Pension Plan Disclosure Statement, seconded by Supervisor Cockley. Supervisor Foltz abstained due to being an employee. Roll Call: Black yes, Cockley yes, Socks yes, Danner yes. Motion carried.
- 5) <u>Planning Commission Year-End Report</u> Supervisor Socks made a motion to accept, seconded by Supervisor Danner. Roll Call: Black yes, Cockley yes, Socks yes, Danner yes, Foltz yes. Motion carried.
