MINUTES

CALL TO ORDER & PLEDGE TO THE FLAG

The June 11, 2012 regular meeting of the Berwick Township Board of Supervisors, Adams County, was held in the Berwick Township Municipal Building, 85 Municipal Road, Hanover, PA. Chairman Robert Foltz called the meeting to order at 6:00 pm. Present were Supervisors Robert Foltz, Fred Nugent, Pete Socks, Earle Black, and Barry Cockley. Solicitor Tim Shultis, Engineer Tim Knoebel, and Township Secretary Karen Eakin were present. Bob Foltz asked all to stand for the Pledge of Allegiance to the Flag.

CITIZENS COMMENTS

EAGLE VIEW – Bea Haskins asked about the Eagle View inspection which Mr. Erwin did not attend. There was a discussion of the issues in the development which have not been addressed.

Mr. Erwin cancelled the Eagle View community yard sale. There was a request to use the Township property for the yard sale. There was discussion of the issues involved.

UNITED HOOK & LADDER – The Supervisors' signatures were needed for approval of changes in Fire Alarm Box Cards. There was discussion on the areas that are covered by each box and the equipment sent out for fire alarms. Bob Foltz made the **motion** to sign the Cards, Pete Socks seconded. Motion is passed with 5 yeas.

Report was given on fire alarms and medical calls made by United Hook & Ladder for the month of May in Berwick Township and the surrounding areas.

SOLICITOR'S REPORT

STORMWATER MANAGEMENT ORDINANCE REVIEW – A draft of the revision to the Stormwater Management Ordinance was presented to the Board of Supervisors. The Supervisors will inform the Solicitor of any comments or questions pertaining to the revised Stormwater Management Ordinance.
