#### **BERWICK TOWNSHIP ORDINANCE NO.** 96

# AN ORDINANCE PROVIDING FOR FINES AND PENALTIES FOR VIOLATION OF TOWNSHIP ORDINANCES

BE IT ENACTED AND ORDAINED by the Board of Supervisors of Berwick Township, Adams County, Pennsylvania, hereinafter referred to as the "Township", as follows, to wit:

#### SECTION I - STATUTORY AUTHORITY

This ordinance is enacted under the authority of and pursuant to the provisions of the Act of Assembly dated May 1, 1933, P.L. 103, No. 69 §1601, reenacted and amended November 9, 1995, Pl. 350, No. 60 §1; 53 P.S. §65101 et seq. specifically §66601, known as "The Second Class Township Code".

#### **SECTION II - PURPOSE**

This ordinance is enacted for the purpose of making uniform the provisions of any ordinances previously adopted by and in effect in the Township with respect to fines and penalties rendered after judgment in civil proceedings before a district justice. Any fines or penalties established pursuant to the Motor Vehicle Code or other statutory authority of the Commonwealth of Pennsylvania shall be in accordance with those statutes.

#### **SECTION III - PENALTIES**

a. If any person, partnership, firm, association, or corporation shall violate the provisions of any ordinances dealing with a building, housing, property maintenance, health, fire or public safety code or ordinance or for water, air and noise pollution violations, the fine for such violations shall, upon a decision being rendered against the individual or entity in a summary proceeding, not to exceed \$1,000.00 together with court costs, including reasonable attorney's fees incurred by the Township.

b. The fine for the violation of any other ordinance shall not exceed \$600.00 together with court costs, including reasonable attorney's fees incurred by the Township.

c. No judgment shall be imposed until the date of determination of a violation by the district justice.

d. If the defendant in the civil proceeding neither pays nor timely appeals judgment, the Township may enforce the judgement pursuant to the applicable rules of civil procedure.

#### SECTION IV - ENFORCEMENT

The Township's police officers, the building permit officer, and such other individuals designated by the Board of Supervisors for enforcement of ordinances shall initiate civil enforcement proceedings as required to achieve compliance with the Township's ordinances. As part of such enforcement proceedings the aforementioned individuals shall determine the fine to be imposed within the guidelines promulgated in Section III.

#### SECTION V - SEVERABILITY AND CONSTITUTIONALITY

It is the intention of the Township that each section or portion of any section of this Ordinance shall be a separate provision and all shall be independent of all other provisions herein, and it is further the intention of the Township that if any section or portion of any section shall be declared to be unconstitutional, invalid, illegal, or unenforceable by any court of competent jurisdiction, such decision shall not affect the validity of any of the remaining sections or parts thereof of this Ordinance. It is hereby declared as a legislative intent that this ordinance would have been enacted had such unconstitutional, invalid, illegal or unenforceable provision not have been included herein.

### **SECTION VI - REPEALER**

All ordinances or parts of ordinances which are inconsistent with this Ordinance are hereby repealed to the extent of such inconsistency. The following ordinances and any subsequent amendment is are specifically amended by this Ordinance although this list shall not by exclusive, it being the intent of the Board of Supervisors to amend all ordinances:
