ORDINANCE NO. 2018-03

AN ORDINANCE REPEALING BERWICK TOWNSHIP'S ORDINANCES NO. 6, 15, 18-90, AND 58

WHEREAS, on December 10, 1984, the Board of Supervisors enacted Ordinance No. 6, entitled an Ordinance regulating the Construction or Placing of any Building or Other Structure in Berwick Township and Prescribed Penalties for Violations; and

WHEREAS, on December 28, 1987, the Board of Supervisors enacted Ordinance No. 15, entitled an Ordinance Regulating the Construction or Placing of any Building or Other Structure in Berwick Township and Prescribed Penalties for Violations; and

WHEREAS, on August 13, 1990, the Board of Supervisors enacted Ordinance No. 18-90, entitled an Ordinance of Berwick Township, Adams County, Pennsylvania, Amending Section 4 of Ordinance No. 15 (Adopted December 28, 1987) which Establishes the Qualifications of the Permit Officer; and

WHEREAS, on March 25, 2002, the Board of Supervisors enacted Ordinance No. 58, entitled an Ordinance of Berwick Township, Adams County, Pennsylvania, Amending Ordinance Number 15 (Adopted December 28, 1987); and

WHEREAS, Berwick Township now desires to repeal those the aforesaid Ordinances.

NOW THEREFORE, be it Enacted and Ordained by the Board of Supervisors of Berwick Township as follows:

1. Ordinances 6, 15, 18-90, and 58 are hereby repealed.
2. The provisions of this Ordinance are severable. If any sentence, clause, or section of this Ordinance is, for any reason, found to be unconstitutional, illegal, or invalid, such unconstitutionality, illegality, or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, or sections of this Ordinance. It is hereby declared to be the intent of the Board of Supervisors of Berwick Township that this Ordinance would have been adopted had such unconstitutional, illegal, or invalid sentence, clause, or section not been included herein.

3. All ordinances or parts of ordinances inconsistent with this Ordinance are hereby repealed insofar as they may be inconsistent herewith.

4. This ordinance shall become effective five (5) days after its adoption.
