**ORDINANCE NO. 32**

AN ORDINANCE OF THE BOARD OF SUPERVISORS OF BERWICK TOWNSHIP, ADAMS COUNTY, PENNSYLVANIA, DEFINING DISORDERLY CONDUCT AND PRESCRIBING PENALTIES FOR THE VIOLATION THEREOF.

**WHEREAS**, THE BOARD OF SUPERVISORS of Berwick Township has determined that it within the powers of said Board to provide for the health and safety of its citizens and to adopt the following.

**BE IT ORDAINED** by the Board of Supervisors of Berwick Township, Adams County, Pennsylvania

101. Disorderly Conduct Defined. Disorderly conduct at any place within the confines of Berwick Township shall be and is hereby defined as any willful act, work or conduct causing or tending to cause any disturbance of the public or private peace, good order or morality or causing or tending to cause any danger, discomfort, or annoyance to any inhabitant or other person whatsoever within the Township, whether on its thoroughfares or private property, or the making of any loud, boisterous, and unseemly noise or disturbance to the annoyance of the peaceable residence nearby, or near to any public highway, road, street, lane, alley, park, square or common, whereby the public peace is broken or disturbed, or the traveling public is annoyed. Disorderly conduct shall include but not limited to fighting, inciting others to fight, drunkenness, vagrancy, begging, profanity, and the use of indecent or immoral language, acts of public indecency, reckless or careless driving or other use of vehicle by owners or operators thereof which shall endanger the safety of persons or property or interfere with the comfort and convenience of any person in the Township, the squealing of tires by reason of fast turns or rapid acceleration, loafing or loitering upon the sidewalks and other public places so as to interfere with the free and full passage of other persons or vehicles, the loitering or prowling or trespassing on private property without permission of the owner or occupants, throwing stones, snowballs or other missiles on, through, or so as to land on any public thoroughfare, reporting any false alarm of fire, the tampering with or destroying any Township or other public lights, signs or property, the operating of snowmobiles, mopeds, or motor bikes on the sidewalks of the Township.

102. Penalties. Any person, firm or corporation who shall violate any provision- of this Part 1 shall, upon conviction thereof, be sentenced to pay a fine of not more than three hundred 00/100 (\$300.00) Dollars; and/or to imprisonment for a term not to exceed ninety (90) days.

This ordinance shall become effective five (5) days from adoption hereof.
