BUSINESS

1) **Fall Fest Discussion**

Eagle View is having water problems and may not have hydrant service. They do not have regular water pressure again. They are changing retention ponds and stormwater management. They need to get a permit from DEP to haul water into the park, and they do not have enough of water supply. May want to check with York Water.

Tom Danner made a motion for the Solicitor and Engineer give the Board direction on whether we should suspend permits in Eagle View Mobile Home Park until the earthmoving and water supply are resolved, seconded by Scott Kenneth. **Roll Call: Black – yes, Cockley – yes, Socks – yes, Danner – yes, Kennedy – yes. Motion carried.**
