ORDINANCE NO. 2023-07

AN ORDINANCE OF THE TOWNSHIP OF BERWICK, ADAMS COUNTY, PENNSYLVANIA, AMENDING ORDINANCE NO. 2016-1

WHEREAS, the Township has authority under Sections 4902 and 6109(a)(7) of the Pennsylvania Vehicle Code to impose weight restrictions and to prohibit use of Township roads by overweight vehicles under certain circumstances; and

WHEREAS, Ordinance 2016-1, provides, *inter alia*, and establishes weight limits for Township Roads, and penalties for violations of the regulations; and

WHEREAS, it is the desire and intent of the Board of Supervisors of Berwick Township to amend Section 4 of Ordinance No. 2016-1, by adding Stanley Drive (T-702) and Little Avenue (T-701) to the streets, avenues and alleys within Berwick Township where the weight limit is 10 tons.

NOW THEREFORE, be it **ENACTED** and **ORDAINED**, by the Board of Supervisors of Berwick Township that Section 4 of Ordinance No. 2016-1, is hereby amended and restated as follows:

- 1. Section 4. Weight Limits for Township Roads Established. Based on the results of engineering studies, the weight limits applying to the following streets, avenues and alleys within Berwick Township is 10 tons:
 - a. Race Track Road (T-505)
 - b. Kinneman Road (T-506)
 - c. Hershey Heights Road (T-499)
 - d. Lobell Road (T-507)
 - e. Bair Road (T-504)
 - f. Stanley Drive (T-702)
 - g. Little Avenue (T-701).
- 2. If any sentence, clause, section or part of this Ordinance Amendment for any reason is found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, sections or parts of the remaining provisions, sentences, clauses, sections or parts of this Ordinance. It is hereby declared as the intent of the Board of Supervisors of Berwick Township that this Ordinance would have been adopted had such unconstitutional, illegal or invalid sentence, clause

or section or part thereof not been included herein.

- 3. All parts of Ordinance No. 2016-1, as amended, which are inconsistent with the provisions of this Ordinance Amendment are hereby repealed or rescinded only to the extent of the inconsistency.
- 4. The provisions of this Ordinance shall become effective five (5) days after its enactment.
