APPROVE CONSENT AGENDA

Scott Kennedy made a motion to accept the bids from Pumping Solutions, Inc. for Contract #1 - \$2,031,797.00; Contract #2 - \$201,120.00; Contract #3 - \$125,910.00; Contract #4 - \$87,370.00 subject to the Solicitor's review of the bid documents, seconded by Earle Black. Roll Call: Black - yes, Green - yes, Socks - yes, Kennedy - yes, Danner - yes. Motion carried.

Pete Socks made a motion authorizing the Engineer to respond accordingly regarding the user rates, seconded by Scott Kennedy. Roll Call: Black — yes, Green — yes, Socks — yes, Kennedy — yes, Danner — yes. Motion carried.

Pete Socks made a motion to commit to funding the \$294,979.00 shortfall, seconded by Bill Green. **Roll Call**: Black — yes, Green — yes, Socks — yes, Kennedy — yes, Danner — yes. **Motion** carried.

2) Legacy Eagle View LLC - Conditional License

Tim Knoebel stated there are questions that will need follow up regarding the fire hydrants.

Tim Shultis was authorized to send a response to Legacy Eagle View on motion of Pete Socks, seconded by Scott Kennedy. Roll Call: Black — yes, Green — yes, Socks — yes, Kennedy — yes, Danner — yes. Motion carried.

3) 1387 Abbottstown Pike - Indemnification agreement & Well permit amendment

Tim Knoebel explained they received a well permit, and through the construction process moved the well to a new location without a revision to the permit and the well is located too close to the stormwater infiltration area. We are proposing an indemnification agreement as part of the completion of the home and U&O. If the Board is agreeable, we can issue a revised permit, and Mr. Myers has already indicated a willingness to sign the agreement.

Pete Socks made a motion to issue a revised permit and have them sign an indemnification agreement at the property owners' expense, seconded by Bill Green. Roll Call: Black — yes, Green — yes, Socks — yes, Kennedy — yes, Danner — yes. Motion carried.

4) Deer Trail Drive - sight distance

The report we received from LTAP states the sight distances are adequate, and a traffic light is not warranted. The township could consider installing a stop line to ensure drivers are stopping at a location that provides them with a maximum sight distance.

5) Municipal Road - sinkhole

Bill Green made a motion to authorize Conewago Contractors to repair the sinkhole on Municipal Road, seconded by Earle Black. Roll Call: Black — yes, Green — yes, Socks — yes, Kennedy — yes, Danner — yes. Motion carried.

6) Race Track Road - Final payment request

Earle Black made a motion to approve the payment request to New Enterprise Stone & Lime Co., Inc. in the amount of \$362,556.57, and withholding \$10,000.00 for potential repairs in an area that will need to be revisited, seconded by Bill Green. Roll Call: Black — yes, Green — yes, Socks — yes, Kennedy — yes, Danner — yes. Motion carried.

SOLICITOR REPORT

1) Delinquent sewer accounts

Account #2053 filed bankruptcy, and we are waiting on the court. Account #2073 sheriff's sale is scheduled in early January 2026.

Municipal claims were filed for 4 other accounts.

- 2) Will be working on the zoning ordinance amendment on gas stations for convenience stores.
- 3) UH&L Loan of \$175,000 will need to come from unappropriated funds.
